### STATUTORY REQUIREMENTS

Parental engagement and consultation

The statutory guidance declares that schools should engage regularly parents and work closely with them when developing and delivering RSE.

Schools must:

Have a written policy for RSE and relationships education which is available to parents.

Consult parents in developing and reviewing the policy.

Clearly communicate parental rights for withdrawal (and good practice is "likely" to include the headteacher discussing with parents the benefits of sex education and the detrimental effects on children of withdrawal).

# WHAT MUST SCHOOLS ENGAGE PARENTS ON?

From September 2020, the law requires primary schools to consult on their Relationships Education policy.

Engagement is a positive step.

Parental engagement surveys Engagement means schools providing the opportunity for parents to feed in their views on the school's proposed Relationships Education policy, and includes considering whether any strongly held views of their parent body should lead the school to adapt when and how they approach certain topics with their pupils.

# **STARTING POINTS**

Nothing new – relationships covered through PSHE education

Primary content is VERY different from the secondary content

About inclusion and respecting others

Clarify it is about understanding relationships not promoting them

All religions will have respect for each other and loving each other at the foundation

The broad process for engagement should involve the school providing clear information to all parents, in an accessible way

### **SEX EDUCATION**

RSE has not had an impact on Sex education provision

Still not compulsory

DfE recommends that 'all primary schools should have a sex education programme tailored to the age and the physical maturity of schools' Department for Education

Statutory guidance for governing bodies, proprietors, head teachers, principals, senior leadership teams, teachers

### SENSITIVE ISSUES

No parental veto – it is statutory

Faith communities – referencing LGBT

The Muslim Council of Britain is currently consulting concerned parents. It has said, "Numerous MCB affiliates and concerned parents have approached the Muslim Council of Britain expressing their concern and requesting guidance, on the apparent erosion of parental rights and the potential exposure of young children to graphic sexual images and concepts from a very young age". Many Muslim teachers are also calling for clarity on what they may be expected to teach in Relationships & Sex Education classes.

Lessons will introduce information too early for the children

# FAITH COMMUNITIES


\*Most faith bodies have been supportive of the changes to RE/RSE

The Catholic Education Service: "The content of the Government's draft guidance is compatible with a Catholic approach to RSE."

Church of England "We welcome the fact that health education has been included in the statutory guidance and are confident that this will help inform and enrich RSE programmes of study as well as helping support pupils at a time when there are growing concerns about the rise in the number of pupils reporting mental health problems."

The Office of the Chief Rabbi has recently published a Guide for Orthodox Jewish schools on the welfare of LGBT+ pupils.

The Jewish News has reported that Orthodox Jewish educators welcome the opt-out for parents in the Government's proposed new guidance on sex-education in schools



### ENGAGEMENT WITH PARENTS

Use the established structures to connect with parents

DfE statutory guidance states: 'Parents should be given every opportunity to understand the purpose and content of Relationships Education and RSE. Good communication and opportunities for parents to understand and ask questions about the school's approach help increase confidence in the curriculum'.

PSHE education is a partnership between schools and parents

Reiterate that parents play a vital role with you in the school to educate their child so they deliver a balanced curriculum

# SUCCESSFUL APPROACHES

Communicating with parents about all of PSHE education from the moment their child starts at the school. This is more likely to lead to a positive view of the subject and an understanding of its breadth and content.

Policy consultation – for example, involving parents in a working group, reviewing or establishing the RSE policy

Parent surveys – establishing parents' current understanding of RSE, questions and concerns. This can be used to plan open evenings/information events/communications between school and home

Open door policy – encouraging parents to come into school to meet with their child's teacher

Information evenings – explaining what will be taught and sharing resources that will be used

Providing advice on how to talk to children about relationships and sex at home

Publishing your PSHE education curriculum on the school website

Publishing FAQs on PSHE education, including RSE, on the school website

# **OPENING UP CONVERSATION**

Stage 1

Engagement process should be information and briefing

Stage 2

Relationships Education & RSE guides to supporting parental engagement

Suitable method to gather parent views (written, online or face-to-face)



### WHERE TO GO FOR HELP
